Vendors may only sell merchandise which is listed above, shown in the photographs that accompany this application, and have been approved by the Maize Days Committee jury. The Maize Days Committee reserves the right to refuse any vendor or the sale of any product. If the booth application is not accepted for any reason, all monies paid will be refunded.

\*All vendors are required to purchase a One-Day Business License from Layton City and the cost of said license is included in the booth rental fee.

A booth space is an uncovered 10' by 10' wide space on the grass. Electricity is ONLY available for food vendors. Vendors are required to provide their own booth structure, tarps, tables, chairs, etc. The Maize Days committee would strongly encourage artisans to work on projects during the festival so visitors can see you at work. Booth spaces are assigned randomly. Displays must be confined to the booth space and not encroach on walkways. More than one vendor can share a booth space.
